Ms. Erwin moved, Ms. Lycos seconded a motion to approve the consent agenda as presented. Roll Call Vote: Rhodes – Y; Musolf – Y; Lycos - Y; Erwin – Y; Lott - Y. Motion passed 5-0.

**Home Economics Presentation**

**Action Items**

Ms. Erwin moved, Ms. Musolf seconded a motion to select Josh Storey as a member of the Webberville Board of Education for the term beginning January 2025 and ending December 2026. Roll Call Vote: Rhodes – N; Musolf – Y; Lycos - N; Erwin – Y; Lott - N. Motion failed 2-3.

Ms. Lycos moved, Ms. Erwin seconded a motion to approve the May 2025 ballot proposal for the operating millage renewal as presented in the resolution. Roll Call Vote: Rhodes – Y; Musolf – Y; Lycos - Y; Erwin – Y; Lott - Y. Motion passed 5-0.

Ms. Lycos moved, Ms. Lott seconded a motion to approve the purchase of football jerseys from BSN not to exceed \$12,000. Roll Call Vote: Rhodes – Y; Musolf – Y; Lycos - Y; Erwin – Y; Lott - Y. Motion passed 5-0.

**Board Vacancy Appointment Discussion & Action**

Ms. Lott moved, Ms. Rhodes seconded a motion to appoint Amy Coe to a vacant board seat. Roll Call Vote: Rhodes – N; Musolf – N; Lycos - N; Erwin – N; Lott - Y. Motion failed 1-4.

The board discussed options for selecting individuals for the vacant board seats. Ms. Lycos suggested returning to the rankings process and Ms. Musolf suggested that the board interview the candidates.

Ms. Rhodes moved, Ms. Lycos seconded a motion to revert back to the rankings process started at the committee meeting the previous week. Roll Call Vote: Rhodes – Y; Musolf – N; Lycos - Y; Erwin – N; Lott - Y. Motion passed 3-2.

Board members utilized the ranking process to select two candidates to forward Ms. Coe and Mr. Rockey for a vote.

Ms. Lycos moved, Ms. Lott seconded a motion to select Amy Coe to fill a vacant board seat beginning January 2025 and ending December 2026. Roll Call Vote: Rhodes – Y; Musolf – N; Lycos - Y; Erwin – N; Lott - Y. Motion passed 3-2.

Ms. Rhodes moved, Ms. Lott seconded a motion to select Joshua Rockey to fill a vacant board seat beginning January 2025 and ending December 2026. Roll Call Vote: Rhodes – Y; Musolf – N; Lycos - Y; Erwin – N; Lott - Y. Motion passed 3-2.
